## Representative fees:

- \$350.00 Representative Fee
- Airfare\*\* (Round trip to/from nearest city to judge and show site / parking to be in addition not to exceed \$15 per 24 hours) to be reserved by show host.

- Hotel accommodations – to be reserved by show host. (2 nights for fly-ins; 1 night for driving more than 4 hours one way unless other arrangements are agreed upon (must be in writing and sent in to ICBR))

## Cancelation notice:

If above said representative is unable to fulfill this contract, and/or it is less than 30 days from show date, all fees that host has paid (hotel that charged a cancelation fee &/or airfare) will be reimbursed immediately without delay. Failure to do so will result in removal from the ICBR representative list and will not be able to reapply until all monies are paid with an inconvenience fee of \$100 (to be paid to the show host).

It is also said and understood that ICBR is **not** responsible for any fees owed, monies due, unfulfilled contracts, etc. between representative and show host. All representatives are independently contracted.

If said show host is unable to fulfill this contract &/or cancel show without a new date, host must give said representative written notice within 30 days before show date or show host will not be able to host another ICBR show.

## Representative duties:

Spokesperson for ICBR, provide information, answer questions, help the public, add entries into the judges show book(s), permanently register new dogs, and ring steward.

By signing this agreement, both parties agree with the above said terms. Any changes must be in writing and a final agreement sent in to ICBR.
